## La Plata County Land Use Code Reorganization Crosswalk

The table below is provided in an effort to assist the public in evaluating the first draft of the proposed new Land Use Code. The column on the left identifies the chapters and sections that currently exist in La Plata County's Land Use Code. The column on the right identifies where, if at all, the same general topics are addressed in the proposed new code, although the exact language may vary. There is not, nor was there intended to be, an exact one-to-one correspondence between the old and new codes. Rather, we believe the proposed draft represents an improvement to the overall organization of topics appropriate for a land use code.
